### **Historical or Other background of property:**

The house was believed to have been built in 1732 during British colonial time period. During the early 20<sup>th</sup> century location was a Funeral Home for the township. It is speculated that embalming took place on the 2<sup>nd</sup> level of the house. Possible closed off well on property that a child may have died in. Multiple deaths have been documented at the property

### **Time of 1<sup>st</sup> walk through:**

9:45pm: Jesse, Corey, Katie, John

### **Camera positions/angles and placement of other equipment:**

Sony HDR-SR1 camcorder placed stationary in top floor room to the right where door claimed to open by itself. DVR system setup with 2 cameras monitoring the stairs, one camera monitoring access to upper levels, and one camera positioned to view team members at home base on 2<sup>nd</sup> floor.

### **Personal Experiences (not verified by evidence):**

Investigators Corey, Sharon, Angie, and Colleen all had a personal experience.

Corey: I saw a shadow in the room where the dog sleeps down stairs (same time as Sharon).

Colleen: I felt someone lightly pinch my arm near the elbow in the 1<sup>st</sup> room connected to the living room on the 1<sup>st</sup> floor of the house.

Angie: While sitting at home base on the 2<sup>nd</sup> floor, I witnessed a shadow down the hallway near the sewing machine; it appeared to be trying to interact with it. I also heard tapping coming from the false door that lead to the boys' bedroom.

Sharon (psychic/medium): I saw a shadow in the room where the dog sleeps downstairs. And I experienced what felt like a slight finger nail rub against my left forearm. I saw residual energy of a tall large framed man in the master bedroom. There is a woman that walks in front of the kitchen window and goes in the downstairs bathroom. She's very strict. There is nothing harmful there and besides the one woman, everything else feels residual in nature.

### **Recommendations:**
